Originally built in 1852 by James Tobias, Emu Hall sits along the banks of the Nepean River in Emu Plains.

The home was constructed as a single storey sandstone building. The roof was originally covered with shingles that are still present beneath the existing corrugated iron roof. The decorative verandah posts, frieze, brackets and balustrade were most likely installed in the 1880s.

The prominent siting of this Victorian style homestead in riverside grounds, on the Great Western Highway and adjacent to the important nineteenth century river crossings, makes this property a landmark site.

After recently completing a two year restoration Emu Hall now offers many visually stunning spaces in which to hold your function, no matter the size.

Terms & Conditions

PAYMENT TERMS

- A 50% deposit is required to be made to confirm the booking.
- A progress payment is due in the amount of 20% of the price specified above within 28 days of payment of the deposit.
- Payment in full is required no later than 14 days before the function date.
- An additional 2% fee will apply to all credit card payments.

DEFINITIONS AND START DATE

1. This agreement is made between Emu Hall Pty Ltd and the persons/businesses/companies noted in the Venue Booking Confirmation Form (the 'Confirmation Form') as the customer.
2. This agreement is comprised of the Confirmation Form and these Trading Terms and Conditions.
3. The following terms have the meanings as set out in the Confirmation Form.
 - i. Customer - see item 1.
 - ii. Venue Booking Details - see item 2.
 - iii. Payment Terms - see item 3.
 - iv. Goods/Services - such of the goods/services agreed to be supplied by Emu Hall to the customer as specified in the Venue Booking Details.
4. This agreement is made on the date shown on the Confirmation Form or the date that Emu Hall otherwise agrees in writing.

AGREEMENT TO SUPPLY

1. Emu Hall shall supply the Goods/Services to the Customer in accordance with this agreement and as specified on the Venue Booking Details
2. The price is inclusive of GST but exclusive of all other taxes or duties
3. Emu Hall reserves the right to vary the Goods/Services agreed as necessary

OBLIGATIONS OF THE CUSTOMER

Payment of Accounts

1. The Customer shall pay Emu Hall in full for the Goods/Services in accordance with the Payment Terms and this agreement, whether or not any dispute between the Customer and Emu Hall about the amount required to be paid by the Customer under this agreement.
2. In the event of a dispute existing between Customer and Emu Hall about the amount required to be paid by the Customer under this agreement, Emu Hall may require, as a pre-condition to any attempt to resolve the dispute or the filing of any defence to litigation that Emu Hall nominate a solicitor to hold the amount claimed by Emu Hall but in dispute in trust as a stakeholder for the parties until the dispute is settled. Upon such request being made by Emu Hall, the Customer shall pay any amount claimed by Emu Hall to that solicitor's trust account.
3. Where Emu Hall has been provided with a credit card or direct debit authority on behalf of the Customer, Emu Hall shall be authorised to use that authority to arrange for payment of any amounts due under this agreement.
4. To avoid doubt, terms relating to payment of accounts shall survive termination of this agreement.

Refunds and Cancellations

5. The customer acknowledges that in booking a function, they are committing to a specific function date and that due to the nature of Emu Hall's business, in the event of a cancellation it will be unlikely that Emu Hall will be able to rebook the venue and therefore cancellation fees will be incurred by the Customer.
6. No payments made to Emu Hall under this agreement will be refunded.
7. In the event of a cancellation, the following amounts will be due and payable by the Customer to Emu Hall:
 - i. For any cancellation 4 months or earlier than the Function Date, a total of 50% of the total price of the booking; and,
 - ii. For any cancellation between 4 months and 2 weeks of the Function Date, a total of 75% of the total price of the booking; and,

- iii. For any cancellation within 2 weeks of the Function Date, the total price of the booking.

Contractors

8. The Customer shall ensure that all proposed 3rd party contractors file a completed Works Permit no later than 7 days prior to the Function Date.
9. All contractors must have public liability insurance.
10. Emu Hall reserve the right to refuse any contractor access to the Venue/function at their sole discretion
11. The Customer indemnifies Emu Hall against any loss or damage suffered by Emu Hall and caused, directly or indirectly, by a 3rd party contractor engaged by the Customer.

Risk & Liability

12. The Customer is responsible to ensure that Emu Hall is made aware of any special requirements pertaining to the Goods/Services and that Emu Hall relies upon the integrity of the information supplied to it.
13. The Customer acknowledges that Emu Hall shall not be liable for from loss or damage or for consequential loss or the damage of any kind arising out of the supply of the Goods/Services.

DEFAULT

1. Should any party default in this agreement, the party not in default may give notice in writing to the party in default specifying the default and giving the party in default.
 - i. If the default relates to the non payment of monies, three (3) days, or;
 - ii. in any other case, ten (10) days in which to remedy the default.
2. If the default relates to the non payment of monies, Emu Hall shall be entitled to charge interest on all amounts payable at the daily rate of 5% above the Reserve Bank of Australia Cash Rate, and if not paid, shall be added to the amount due to Emu Hall on the 1st day of each month and bear interest from that date.

TERM & TERMINATION

1. This agreement shall continue unless terminated in accordance with this Clause.
2. Once a venue booking has been confirmed by the customer and a Confirmation Form has been signed and accepted, the Customer may not terminate this agreement.
3. Emu Hall may terminate this agreement by giving notice in writing to the other party in the event a default notified in accordance with clause remains unremedied.
4. Upon termination, all monies payable under this agreement become immediately due and payable and Emu Hall shall not be liable to refund any monies paid.

GENERAL

Entire Agreement

1. This agreement constitutes the entire agreement between the parties and supersedes all previous communications, representations, inducements, undertakings or arrangements between the parties.

Severance

2. This agreement is to be interpreted so that it doesn't infringe against the Acts of any Parliament of Australia or any regulations made under those Acts. If any provision is invalid or not enforceable, the remaining provisions which are self-sustaining and capable of separate enforcement shall continue in force.

Amendment

3. Any amendment to this agreement must be in writing and signed by the parties.

Notices

4. Any notice to be given under this agreement shall be in writing and is deemed duly given if it is:
 - i. left at that other party's address;
 - ii. sent by pre-paid mail to that other party's address; or,
 - iii. transmitted by facsimile to that other.
5. Any notice given to a party is deemed duly given and received:
 - i. when delivered (in the case of it being left at that party's address);
 - ii. on the third business day after posting (in the case of it being sent by pre-paid mail); or,
 - iii. on the day of transmission, if a business day, or, if not a business day, on the next business day (in the case of facsimile).

Account Keeping Fees

6. Without prejudice to any other rights of Emu Hall, if there is any amount which is overdue, the Customer may be charged account keeping fees in the amount of 1.5% per month.
7. To avoid doubt, this term shall survive termination of this agreement.

Cost Recovery

8. The Customer shall pay Emu Hall for all costs incurred by Emu Hall in the recovery of any goods or monies owed (including those costs which may be contingent on recovery) by the Customer to Emu Hall under this agreement including debt recovery agents costs, repossession costs, location search costs, process server costs and solicitor/client basis.
9. To avoid doubt, this term shall survive termination of this agreement.

Reservation of Rights

10. All rights not specifically and expressly granted to the Customer by this agreement are reserved to Emu Hall.

Receipt & Charge

11. The receipt of money by either of the parties shall not prevent either of them from questioning the correctness of any statement in respect of any money.
12. To avoid doubt, this term shall survive termination of this agreement.
13. If Customer is an individual, if any amount is overdue, the Customer agrees to charge his/her real and personal property to secure the indebtedness of the Customer to Emu Hall, and authorises Emu Hall to lodge a caveat or register the charge on the Personal Property Securities Register until the overdue amount is received in full by Emu Hall. The Customer shall also be liable for all costs incurred by Emu Hall arising from this clause on an indemnity basis.
14. If Customer is a company, if any amount is overdue, the Customer agrees to grant a fixed and/or floating charge over its assets in favour of Emu Hall and irrevocably authorises Emu Hall to register the charge and Emu Hall's interest in the charge with the Personal Property Securities Register. The Customer shall also be liable for all costs incurred by Emu Hall arising from this clause on an indemnity basis.

Insurance

15. The Customer shall be responsible for whatever insurance cover it requires at its own expense.

Force Majeure

16. Both parties will be released from their perspective obligations in the event of national emergency, war, prohibitive governmental regulations or any other cause beyond the reasonable control of the parties renders performance of the agreement impossible whereupon all money due to Emu Hall shall be paid immediately.

Emu Hall's Right to Assign

17. This agreement and all rights under it may be assigned or transferred by Emu Hall without consent of the Customer.

Waiver

18. The failure by Emu Hall to enforce at any time or for any period any one or more of the terms or conditions of this agreement shall not be a waiver of them or of the right at any one time subsequently to enforce all terms and conditions of this agreement.

Time of Essence

19. Time is of the essence in this agreement in all respects (whether any extension of time or other indulgence has been given by any one party to the other or not) and any breach of a time limit by one party will give the other parties the right to terminate this agreement.
20. To avoid doubt, this term shall survive termination of this agreement.

Governing Law

21. This agreement is to be governed by the laws of the State of New South Wales.
